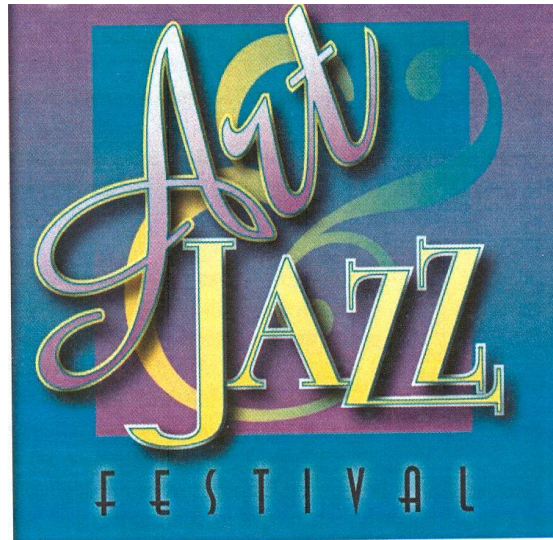


# CALL FOR ENTRY

## **Eligibility Requirements: Artisan Registration / Information**

The Downtown Grand Junction Art & Jazz Festival is presented by the Downtown Partnership.

- Open to artists who exhibit work of their own concept, design and execution in any media.
- The show is juried so overall quality & balance of art displayed will represent the high standards the Festival maintains.
- Entries are judged on quality, creativity and originality of design.
- No manufactured, commercial, imported or kit work will be accepted.
- The artist must personally tend the booth.
- Work on display after the opening of the show will be reviewed by the Festival Committee. Any exhibitor whose work does not meet the standards of acceptability will be required to withdraw from the show without refund.

**All decisions made by the Committee are final.**

## **Artisan Entry and Space Fees:**

The jury fee is \$25 per artist, non-refundable. Space fee is \$230 for a single booth, \$400 for a double booth. The space fee check is not deposited until you are accepted. If you are not accepted, the space fee and the optional electricity check will be promptly returned with your slides/photos/CDs.

- All entry and space fees must be postmarked by March 2, 2012 for judging.
- Once you have been accepted, cancellations must be made in writing and received by March 30, 2012.
- No commission on artist sales is charged.
- Absolutely no space refunds will be given after March 30<sup>th</sup>, 2012.

## **Exhibit Space:**

- Booth space is 10' x 10' and is assigned by the Festival Committee.
- Booth assignment is final and at the discretion of the Committee.
- Each exhibitor must provide their own display booth and equipment.
- **Thirty pound weights are required on each pole.**
- All parts of the display must be within the limits of assigned area.
- The Festival is held outside, so suitable protection from the sun, wind and rain is suggested.
- There is no rain date and there are no refunds for weather.
- Booths may be left in place overnight at the discretion of the artist. Overnight security will be provided.
- The organizers of the Festival are not responsible for loss, theft or damage to any artwork, display facilities or person.
- **NO PETS ALLOWED**

## **Security:**

Security guards will patrol the Festival area Friday and Saturday from 10 pm to 8 am. Although we cannot guarantee the safety of your booth overnight, we hope this will give you peace of mind.

## **Sales Tax:**

Artists must collect sales tax. A chart and tax form will be distributed with your packets.

## **Calendar of Events:**

Friday, March 2nd	Application postmark deadline.
Friday, March 23rd	Notification of acceptance sent.
Thursday, March 30th	Cancellation to receive fee refund.
Friday, May 11th	Artist check-in and set-up. Beginning at 9 A.M.
Friday, May 11th	Booth hours 4 P.M. to 9 P.M.
Saturday, May 12th	Booth hours 10 A.M. to 9 P.M.
Sunday, May 13th	Booth hours 10 A.M. to 4 P.M.

## **Application Procedures:**

1. Sign and complete application.
2. Submit three (3) slides, photos or CD showing current work and the quality and type to be sold.
3. Label all materials with your name, size, price and media of work
4. Include one (1) slide, photo or CD of your booth.
5. Enclose check for booth space fee. (Include \$25 electricity fee if needed). Your booth space fee and the optional electricity check will be returned if your entry is not accepted.
6. Enclose a separate check for \$25 non-refundable jury fee.
7. Enclose a SASE with adequate postage (the same amount that was put on to send it) for the return of your slides, photo or CDs.
